TRANSFER ORDER

At a session of the ____ District Court, held in the City of _____, Wayne County, Michigan on the ____ day of _____, by the presiding judge, the Hon. _____, it has been determined that the defendant shall have his probation sentence transferred to the 17th District Veterans Court. The defendant, _____, and the transferring court understand that certain conditions must be met prior to acceptance into Veterans Court.

THEREFORE, IT IS HEREBY ORDERED that:

1. Defendant plead guilty to _____ on _____.
2. Defendant will be sentenced to ____ month's non reporting probation with this court and to the terms and conditions of probation that will be imposed by the 17th District Veterans Court.
3. This case is transferred to the 17h District Court so the defendant can participate in the Veterans Court Program.
4. The presiding judge over the 17th District Court Veterans Court shall have authority to:
 - a. Return this case to this Court if she determines that the defendant is not eligible for, or does not wish to participate in the Veterans Court.
 - b. Sentence the defendant to probation.
 - c. Oversee the defendant's progress while on probation.
 - d. Discharge the defendant after successful completion of the Veterans Court Probation.
 - e. Impose sanctions or sentences for violations of probation.

- f. Revoke probation and terminate defendant's participation in the Veterans Program. The case will then be transferred back to this Court and defendant will be sentenced as determined by transferring judge.
- 5. The defendant shall appear at the 17th District Court for a pre-sentence investigation upon notice from the 17th District Court. The defendant or the defendant's attorney is responsible for contacting the 17th District Court Veterans Court immediately following sentencing.
- 6. Bond shall remain as set, subject to modification by the 17th District Veterans Court.
- 7. The defendant shall sign the appropriate releases of information allowing the personnel on the Veterans Court team at the 17th District Court to share any and all information related to the defendant, including any medical records, treatment records and the like.
- 8. The following fees shall be assessed:
 - (A) _____ Fines and Costs
 - (B) _____ State Judgment Fee
 - (C) _____ Crime Victim Rights Fund Fee
 - (D) _____ Other

Failure to pay the foregoing is a violation of probation and could result in the defendant's incarceration and/or termination of his or her participation in the 17th District Veterans Court.

Any Probation Supervision fees and Court Appointed Attorney fees for the Veterans Court will be assessed and collected by the 17th District Court.
