UTILITY WORKER

DEPARTMENT: Water Department

REPORTS TO: As Assigned

Purpose: Employees in this classification repair and maintain water department facilities and equipment, and perform related work to support the delivery of township services.

Essential Functions:

Essential functions, as defined under the Americans with Disabilities Act, may include, but are not limited to the following duties, responsibilities, tasks, knowledge, skills and other characteristics. This list of Duties and Responsibilities is ILLUSTRATIVE ONLY, and is not intended to be considered a comprehensive listing of all functions and tasks performed by positions in this class.

Example Duties/Responsibilities:

1. Install and services water and sewer lines and fire hydrants.
2. Digs trenches for new installation, diagnosis or repair to water and sewer related lines
3. Operates a variety of hand and powered equipment to effect the installation, diagnosis or repair.
4. Walks a route to obtain and record water meter readings;
5. Performs routine maintenance on meters and other related equipment.
6. Inspects, cleans, maintains and repairs grates, and pumps;
7. Performs general maintenance as required to keep water and sewer lines operational.
8. Refers customer questions, complaints, and issues to the proper supervision.
9. Performs other duties as assigned or required.

Minimum Qualifications:

1. High school diploma / GED.
2. One year of working experience.
3. Must possess a valid State of Michigan driver's license with five or fewer points at time of hire.
4. Must obtain a valid commercial driver's license (CDL) within 30 days of employment.
5. Must obtain all medical certificates associated with CDL.
6. CDL shall have a group A or B designation.
7. CDL shall have an air brake endorsement.
8. CDL shall remain current throughout course of employment.
9. Employee shall possess five or fewer points on driving record.

Additional Information/Requirements:

1. Must be able to lift and carry heavy, bulky tools, equipment and other items weighing in excess of 50 pounds;
2. May be exposed to hazardous chemicals, fluids, bodily waste and other materials;
3. Must be able to work in all weather conditions;
4. Physical agility and mobility is required in order to work on uneven ground, in construction areas, trenches of various depths, and subterranean structures;

5. Must be able to demonstrate proficiency in the operation and use of motorized vehicles and other equipment.

Knowledge/Skills:

Demonstrate ability with basic electrical and plumbing repair, maintenance and inspection practices and principles;

Demonstrate ability with basic construction techniques;

Demonstrate ability with the principles and techniques of vehicle and equipment operation and general maintenance and repair;

Demonstrate ability with the application and use of variety of hand tools, construction equipment and other tools and materials.
