AN ORDINANCE TO AMEND ZONING ORDINANCE NO. 152-N, THE CHARTER TOWNSHIP OF REDFORD, WAYNE COUNTY, MICHIGAN, BY AMENDING THE ZONING MAP NUMBER 2-13, IN CONNECTION THEREWITH.

THE TOWNSHIP OF REDFORD ORDAINS:

Section 1. The Zoning Map, in connection with the Zoning Ordinance of the Charter Township of Redford, shall be amended to change the zoning of the following described property, to wit:

MAP NO. 2-13: To rezone from C-1, Local Business District to C-2, General Commercial District.

PROPERTY MORE COMMONLY KNOWN AS: 26729 Plymouth Road, Parcel 79-041-01-1993-000


Section 2. All ordinances and parts of ordinances in conflict herewith are repealed hereby to the extent of such conflict.


