**Citizen Comments**

Fire Chief Les Wedge appeared before the park's commission with respect to his idea to have an outdoor skate park in Redford Township. He had two locations in mind; one at Pomona and Five Mile Rds. and the second at or near Kinloch just west of Beech Daly in Lola Valley Park. He had spoken with Mary Haney of the Lighting Commission about lighting and that was not a problem. The area at Five Mile and Pomona Rds. currently has sledding and he would support an outdoor ice rink being placed there to complement the sledding.

Fire Chief Les Wedge spoke fondly of his memories as a child using the outdoor ice skating rink in Lola Valley including warming himself by the outdoor fire and with hot chocolate. He was very enthusiastic about these outdoor ice rinks locations and volunteered to have the Redford Township Fire Dept. flood the area. The Fire Dept would also monitor the use and



maintain these two outdoor ice rinks. He had not contacted anybody yet but wanted the Park Commission's thoughts on the matter and suggested the Parks might want to have an outdoor concession stand to sell such items as hot chocolate and other goods. He intended on contacting our Wayne County Commissioner, Phil Cavanaugh as well.

Kevin Dodd thanked Fire Chief Wedge for his initiative, noting the area was out of the jurisdiction of the Parks Commission as the area was owned by Wayne County.

**07-112 – Motion – Outdoor Ice Rinks at Lola Valley**

- A motion to work with Fire Chief Les Wedge regarding possible new locations for outdoor ice rinks at Lola Valley Park was made by Commissioner Dodd, 2<sup>nd</sup> by Commissioner Offman. All yeas.

**Old Business**

- Baseball Subcommittee, Commissioner Keenan reported that the baseball dugout matter is progressing and he hoped to conclude it by the end of December, 2007.
- Credit card fees: Discussion centered around the credit card fees the Parks and Recreation Department incurs when residents tender payment by credit card for classes. Mike Curle liked the idea because we did not have any collection problems. The latter sometimes is not the case with checks. He will look into the individual cost per transaction with the possibility (subject to this Board's approval) of including the fee in the credit card transaction. Mike stated that he wasn't in favor of charging an extra fee for credit card usage, but if the fees continue to increase, it is something we will need to investigate.

**Department Report**

- Theresa Burgess: The winter flyers are completed. She is working with Echo Media re: the changes in the web-site suggested at the last meeting. Bob Salmonson is going to place a counter on the web site and another template on the front page.
- Mike Curle: He worked on the Christmas parade and enjoyed it. He mentions the budget process is coming and wants the Commission's input on that. Items being considered among others will be a mobile stage, a top-dresser, additional soft landings for the play areas, sidewalks and walkways of cement to make our playgrounds more ADA accessible, red clay for the baseball diamonds, sun-shade screening at the splash park, electronic sign in front Water Dept., the needs of Claude Allison including security and the Little League Diamonds.
